	In case of illness, please sign your child out via the school app or via our office.				
Head lice	Please notify school and us immediately if you notice an infestation of head lice on your child.				
House slippers	Your child will need house slippers in our facilities. Please label them with child's name.				
Clothing	Your child needs appropriate clothing adapted to all weathers and marked with name (cap, rubber boots, sun hat, etc.).				
Kerni etiquette and consequences	Our interaction with each other is friendly, respectful and appreciative. We abide by the agreed rules and respect boundaries and needs of all others. Every child is welcome here. We do not tolerate children being beaten, insulted or ostracized in our Kerni.				
	Parents will be notified in the event of disrespectful, assaultive or violent behavior.				
	Should a child, despite all efforts, not want to or be able to comply with the rules and/or show behavior that exceeds the scope and possibilities of the pedagogical care and represents an unreasonable burden for us and a danger for other children, claras kerni e.V. can terminate the care place (see care contract).				
Parent interviews	Settling-in talks take place approximately 8 weeks after start of care. Further parent meetings are possible at any time by appointment.				
Duty of cooperation	Changes in personal data (account details, telephone, etc.) must be communicated to claras kerni e.V. immediately. Attendance at parents evenings, participation in parents meetings and reading the parents letters is desired.
